9:15 – 9:30 Public Comment on Agenda Items The Pledge of Allegiance was recited.

Laura Kopsa, Auditor, presented a request for a resolution for the American Cares Act funds. Motion by Hilmer, seconded by Faircloth to approve the following resolution:

A RESOLUTION TO APPROVE DISBURSEMENT OF FUNDS FOR THE AMERICAN RESCUE PLAN ACT.

WHEREAS, on March 11, 2021, President Biden signed the 109 trillion-dollar American Rescue Plan Act and, **WHEREAS,** Tama County applied for and has been received funds for the American Rescue Plan Act totaling \$3,200,000.00.

WHERAS, the Tama County Board of Supervisors has reviewed some requests and determined some that will qualify for the American Rescue Plan Act and

WHEREAS, based on the distribution guidelines from the US Department of Treasury, the following projects have been approved for the use in the second round of said funds:

- Tama County Secondary Roads Topographical Program 42,464.00
- Tama County Secondary Roads- Fuel System with FOBS 45,977.37
- Tama County Auditor DS450 Ballot Tabulating Equipment 37,852.40
- Tama County Auditor DS450 Ballot Tabulating Equipment 26,147.60 (LATC)
- Tama County Treasurer Desk 2,500.00
- Tama County Auditor Computers and software 15,000.00
- Tama County 911 Training Reimbursement 6,376.40

BE IT RESOLVED that the Tama County Board of Supervisors endorses the disbursement of American Rescue Plan Act Funds for the items listed and authorizes the Auditor to make these payments as they are presented.

This committee would make decisions on how to spend the funds based on the guidelines in the settlement agreement. They would also generate reports to comply with the settlement agreement. Motion by Hilmer, seconded by Faircloth to approve allowing the Auditor to organize an Opiod Committee to make decisions and oversee the spending of the funds the County receives and to generate reports to comply with the settlement agreement. RESOLUTION TO RENEW 28E INTERGOVERNMENTAL AGREEMENT FOR MENTAL HEALTH & DISABILITY SERVICE NETWORK CALLED COUNTY SOCIAL SERVICES

Whereas Code of Iowa, 2011, Chapter 28E and Chapter 331, Section 331.440(3) "A county may implement the central point of coordination process as part of a consortium of counties and my implement the process beginning with the fiscal year ending June 30, 1995."

Whereas a consortium of counties will provide greater equity of mental health & disability (MH/D) services in the region, Whereas a consortium of counties will provide greater equity of funding services in the region,

Whereas a consortium of counties will provide more flexible administration that will improve the efficiency and effectiveness of plan administration with limited resources,

Therefore, Tama County resolves to renew their 28E Agreement for Mental Health & Disability Services with County Social Services.
