Motion by Wankowicz, second by Raymond to approve agenda. All aye. Motion carried.

Motion by Kucera, second by Wankowicz to approve the January E911 Service Board meeting minutes. All aye. Motion carried.

Public Hearing

Julie advised E911 budget was published on 01/25/2013 in the Tama News Herald & Traer Star Clipper as required—no more than 20 days and no less than 10 days from the date of the Public Hearing. No comments, questions, or concerns have been received through the 911 Office. No public present at the Public Hearing this evening. Motion to adopt E911 Service Board budget as published by Wankowicz, second by Sash. Roll call vote, all aye. Motion carried.

Motion by Sash, second by Raymond to approve claims for payment. All aye. Motion carried.

A discussion ensued regarding the designation of certain departmental bills as recurring. Rather than designating claims, Board members present designated Executive Board member & Sheriff Dennis Kucera to sign off on all 911 claims on a trial basis. The issue will be revisited at the April meeting to see how the arrangement is working.

The next regular E911 Service Board meeting will be held April 9th, 2013 at 7PM in Toledo.

Motion by Raymond, second by Skopec to adjourn at 7:10PM. All aye. Motion carried.
