Emergency Management Agency & CERT Command

The Tama County Emergency Management Commission meeting was called to order at 7:12PM on February 5th, 2013 at the Board of Supervisors Chambers in Toledo. Board members present: Kendall Jordan (Board of Supervisors), Mary Wankowicz (Dysart), Keith Sash (Gladbrook), Roger Green (Montour), Dave Svoboda (Toledo), and Dennis Kucera (Sheriff), and Ryan Currens & Julie Vokoun (Emergency Management). Others present: Joe Boll & Rick Raymond.

Motion by Green, second by Wankowicz to approve agenda with the Public Hearing moved to the end to open at 7:30. All aye. Motion carried.

Motion by Wankowicz, second by Jordan to approve the January EMA Commission meeting minutes. All aye. Motion carried.

Motion by Wankowicz, second by Green to approve claims for payment. All aye. Motion carried.

A discussion ensued regarding the designation of certain departmental bills as recurring. Rather than designating claims, Board members present designated Executive Board member & Sheriff Dennis Kucera to sign off on all Emergency Management claims on a trial basis. The issue will be revisited at the April meeting to see how the arrangement is working.

Motion by Jordan, second by Wankowicz to sign the CodeRED contract for service for another year.

The next regular EMA Commission meeting will be held April 9th, 2013 at 7PM in Toledo immediately following the E911 Service Board meeting.

Ryan distributed disks with copies of ESF 10, 12, 13, & 14 Board members present for review. (Several 911 Board members present also took disks to deliver to their city's EMA designees.) Adoption of the 4 ESF's will take place at the April meeting.

Julie advised Emergency Management budget was published on 01/25/2013 in the Tama News Herald & Traer Star Clipper as required—no more than 20 days and no less than 10 days from the date of the Public Hearing. Motion to adopt Emergency Management Commission budget as published by Wankowicz, second by Sash. Roll call vote, all aye. Motion carried.

Motion by Svoboda, second by Wankowicz to adjourn at 7:35PM. All aye. Motion carried.
