Motion by Skopec, second by Kucera to approve the February 2013 Tama County 911 Services budget public hearing meeting minutes. All aye. Motion carried.

Motion by Weekley, second by Kucera to approve claims for payment. All aye. Motion carried.

Ryan briefed the Board on his quarterly activity report.

Replacement of Comm Center Cameras

Ryan advised the cameras currently in place are at the end of their lifespan. Several members of the dispatch staff as well as their Union Representative were present to protest the need to replace the cameras. Motion by Weekley, second by Kucera to replace only 1 of the cameras. All aye. Motion carried.

Automatic Paging of Fire

A discussion ensued regarding automatic paging of the fire department to follow the ambulance on motor vehicle accidents. After discussion, it was decided that there would be no change to the current protocol. The incident prompting the discussion was an isolated incident and would be worked out between the involved agencies.

The next regular E911 Service Board meeting will be held July 9th, 2013 at 7PM at the Traer Fire Station.

A discussion regarding the ongoing radio problems was introduced. Ryan & Julie assured that all complaints received by them were being forwarded to Radio Communication. Joe will be CC'd on all complaints to RC.
