Boll advised he would like to move agenda item “Grievance Presentation” to the second item on the agenda. Motion by Kucera, second by Weekley to approve agenda with said change. All aye. Motion carried.

Motion by Weekley, second by Raymond to purchase a white 2014 one ton pickup from Bill Colwell Ford at \$24,550 with EMPG funds and EMA vehicle replacement fund match to replace the current EMA vehicle. All aye. Motion carried.

The Board reviewed and made suggestions to the EMA/911 Director job posting and suggested using as many free sites as possible to place the ad in addition to the 2 required Tama County publications.
