### **911 Services Department**

The Tama County Emergency Management Executive Commission meeting was called to order at 6:00 PM on January 17, 2017 by Chairman Dave Svoboda (Toledo) Members present: Kendall Jordan (Board of Supervisors) Sheriff Dennis Kucera, Gordon Fassett (Clutier), Mindy Benson EMA Coordinator, Jeremy Cremeans EMA Assistant. Also Present Billie Van Egmond, and Joe Boll.

Motion by Fassett, second by Jordan to approve the agenda. All ayes. Motion carried.

Mindy presented the members with a proposal of the items for the budget hearing and set the hearing date for the EMA budget for February 7, 2017. During this time Joe Boll also brought up the discussion of pay and salary for Mindy and Jeremy. Mindy did state that she would like to see Jeremy get a rate increase to get him at more of an administrative pay rate. The board decided to place Jeremy at a 3.2% pay raise. It was also discussed that the current Union contract is still being determined for dispatch pay rate and contract negations, members present stated that dependent on dispatch received they may go back and reevaluate Mindy and Jeremy's pay/salary.

Mindy and Jeremy spoke to the members about the necessity of a second EMA vehicle. The members did agree there is a need for a second EMA vehicle. At the date and time of the meeting Karl Chevy in Ankeny had a 2016 Chevy Tahoe that was equipped and for sale as a demo, they were asking \$40,000. The board approved Mindy and Jeremy to deal with Karl Chevy Emergency Vehicle Sales personnel Rob Long on the vehicle.
