The work included: **Otter Creek Park and Hansen Addition** beach ropes in, shower-house open, re-seed north loop trench lines, stain picnic tables/repair, mow Parcel B, mow lake and road edges, fix barrel on beach playground, new roof- tent section restroom. / **TF Clark Park** cut up downed tree./**Wolf Creek Trail** – mow trail and cut up downed trees./ **McCoy Landing** correct problems in approach to ramp. /**Naturalist Report** The monthly report for May drafted

by Logan Roberts, Naturalist, was presented to the Board. May was a very busy month with twelve different activities reaching nearly 600 people./ **Seasonal Staff** All seasonal staff positions have folks on the ground working with the last starting on May 4./ **Izaak Walton Shooting Facility- Signup Meeting** Etzel reported the last si gnup meeting was held on May 22 at the Tama County Nature Center. Nine people became authorized at the meeting bringing the total of authorized shooters to 112. Persons interested in becoming authorized will be sent a test with a study guide. If they successfully pass the test they will make arrangements to either come to the office, pay their fee and be issued a range use card and key <u>OR</u> they can mail a \$60 check and the card and key will be mailed to them. Etzel reported he had one person already become authorized by taking the test./ **Heritage Wetlands Wildlife Area- Pollinator Planting** Etzel reported that nearly twenty acres was planted last week at the tract. The acreage was planted as follows: Pheasants Forever Firebreak mix on 3.6 acres, 8.1 acres in a prairie forb/grass mix suited for butterfly habitat, and 8.1 acres in a prairie forb/grass mix providing bee habitat. The forb/grass mix was provided at no cost (estimated value of \$7,000) through a grant received from the Bee





and Butterfly Habitat Fund. Also the Board voiced their gratitude for the Tama Soil & Water Conservation District Commissioners' donation of the operator, tractor and seeder to plant the seed.

Fifth Wheel Trailer The Board considered bids submitted for a fifth wheel trailer. The current trailer is getting old and requiring increasing costly repairs. The trailer recommended best for our operation is a 24' gooseneck, low deck electric hydraulic tilt. The trailers have a wide (102") floor with rub rails and drive over fenders.
