Reports and Correspondence. Maintenance Report Wise updated the Board on work started or completed during October. The work included: Otter Creek Park and Hansen Addition Fall Festival- set-up and tear down, trimming along hiking trail, winter shut-down of some park components, cage & trim landscape trees, south loop renovation- water line project- work relative to prepping south loop for construction, winterization of equipment/ TF Clark Park trim trees./ Naturalist Report The Naturalist Report was shared with the Board regarding October programming (313 people reached)./ Meetings/Workshops Attended All staff attended the District 1 meeting in Poweshiek County on 4Oct, Etzel, Wise attend CCPOA training at Camp Dodge 9- 10Oct, Wise, Rieger attended Pesticide Certified Applicator class on 17Oct../ Fall Festival The Board discussed the Fall Festival held on 7Oct. Weather



was not the friend of this year's event however a decent turnout was present. It was pointed out it was encouraging to see little kids attending with their families for the day's activities../ Walleyes On 23Oct 600, 6"- 8" walleye were stocked into Otter Creek Lake./ Grants- Prairie Partners Grant It was reported that a grant from the Prairie Partners Program has been secured for seed to plant a pollinator planting at the Reinig Wildlife Refuge and Nature Study Area. The grant will be used to retire the crop field at the facility and was valued at \$5,740./ South Loop Camp Area Renovation Staff updated the Board on the work underway to renovate the South Loop camp area at Otter Creek Lake and Park. Work has included setting the electrical distribution panel, pulling all the old pedestals, setting new transformers and sentry pole. Water service work has included running two inch line from the well house down to south loop. It is hoped the electrical and waterline work will be completed in the next 10- 14 days, After water & electrical work is complete construction of the six new back in campsites will be pursued. Two of the back-in sites will be built to ADA accessible standards.

Transition to New Director The Board, with the assistance of Tammy Wise, Human Resources, had an in-depth review and discussion of the job description and the housing policy documents.



Cessford/OMG Property Etzel relayed that he had been in contact with representatives of Cessfords/OMG regarding naming of the property. An example of a facility sign for the area was shared. The sign reflects the language the corporation requested to recognize their donation of the property. After discussion it was moved by Adolphs, seconded Atchison that the property be named Oxbow Bottoms Wildlife Area and that the language requested by the donor is acceptable for placement on the facility sign, carried. (all voting aye)

The Board discussed lack of progress on the ROW easements as requested by adjoining landowners.

lowa Americorps 4-H Environmental Education Program Word has been received that a grant has been awarded to the conservation board to participate in the program during 2019. The grant is to help fund a quarter-time position for an environmental education intern during spring into midsummer, 2019. The county share of the grant is \$1,800.

Etzel shared the agreement for the grant and explained that notice has been received that the county must enter into the agreement (due November 19) and pay the county share by December 3. There were a few requirements in the grant that Etzel would like to discuss with human resources prior to signing the agreement.

After discussion it was moved by Atchison, seconded Adolphs that the board enter into the agreement to participate in the Iowa Americorps 4-H Environmental Education Program contingent upon consideration and approval of the grant requirements by Tama County Human Resources, carried. (all voting aye)

Moved by Atchison, seconded Adolphs that Etzel will serve as agent for the Board in signing all documents relative to participation in the Iowa Americorps 4-H Environmental Education Program, carried. (all voting aye)

Other business Etzel relayed that four pieces of county conservation equipment had been placed for sale on Craig's list. The equipment was no longer of value to the daily operations of the board. The items are 1991 International 4900 dump truck, 1985 Cronkhite hauling trailer, 1973 International 1000 sickle mower, and Ford 910 6' rotary mower. He reported the Cronkhite trailer had been sold for \$2,500. A check has been received for the International sickle mower for \$300 but had not been picked up yet. Two persons are planning to look at the rotary mower but no legitimate interest has been shown to date for the dump truck.



After discussion of several conservation topics it was moved by Atchison, seconded Adolphs to adjourn, carried. (all voting aye) Adjourned 9:00 p.m.
