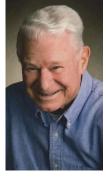
Reports and Correspondence. Maintenance Report Wise updated the Board on work started or completed during December. The work included: Otter Creek Park and Hansen Addition cut/spray invasive vegetation- Parcel A- Hansen Add, pull silt fence posts- Parcel C- Hansen, burn various locations, annual inventory, rebuild hydraulic cylinders (2), Spillway- repair cracks in wall, re[air men's shower and trailer duct tube./ Naturalist Report The Naturalist Report was shared with the Board regarding December programming (215 people reached)./ Board member appointment Bryan Wacha has been appointed by the Board of Supervisors to serve a five year term on the conservation board. The term will run from January 1, 2019, through December 31, 2023./ Americorps lowa 4-H Environmental Education Grant Reported that position will be posted in the next week./ South Loop Camp

Area Renovation Progress has been slow but it was reported the waterline work was

completed. The site is very rough due to the work being completed after frost was in ground. Challenge will be getting north loop and camper's hill campgrounds accessible for camping in the spring while the work in south loop is completed./ Past Board Member Recognition Word had been received that Rich Beecher, Conservation Board member from 1959- 1988, passed away on December 10 at the age of 90. Beecher was very influential in establishing a conservation board in Tama County and in the establishment of Otter Creek Lake and Park. Rich was very active obtaining signatures on petitions to get the question to have a CCB in Tama County on the ballot in June (unsuccessful) and November (successful), 1958. He was named the first chairman of the Conservation Board at the inaugural meeting in January, 1959 (at the young age of 30). He was a proponent of a centrally located lake and park facility in the county so that any county resident, regardless of financial status, could drive 30 minutes to a place to enjoy nature, fish, camp, boat and picnic. This vision and drive resulted in the Otter Creek Lake and

Park facility. The Board recognized Rich's significant contribution./ **SWCD Donation** Word has been received that the Tama Soil & Water District Commissioners have donated the cost of drilling pollinator seed mix at the Reinig Wildlife Refuge and Nature Study area. The Conservation Board voiced great appreciation for the ongoing support of the SWCD.//**Traveling Exhibit** It was reported the prairie exhibit that was initially planned for placement in the Nature Center in February will not be available until fall. It is hoped the exhibit will be shown during November./ **Oxbow**

Bottoms Wildlife Area Fencing- Junior Jack has been contacted and project is on his list for fencing work in the spring.

Tama County Community Foundation Etzel approached the Board regarding submitting a grant application to the Tama County Community Foundation. The project proposed is development of ten science curriculum bins to be used in various ways in our program. Total cost anticipated to be approximately \$10,000



with \$7,000 being requested in the grant application. The remainder of the funding will come primarily from the Nature Center Trust Account. After discussion it was moved by Wrage, seconded Adolphs that a grant application be made to the Tama County Community Foundation for development of ten science curriculum bins, carried. (All voting aye)

Transition to New Director Tammy Wise, Human Resources, approached the Board regarding suggested changes to the Housing Policy by the Heartland Insurance Risk Pool counsel. After reviewing the suggested changes and discussion it was moved by Wrage, seconded Atchison to accept the Housing Policy as presented, carried. (All voting aye)

Etzel reported the job opening (Director) was posted on MyCountyParks.com on January 8. Ads will appear in local papers the weeks of January 14 and 21. Applications will be due by February 8.

Keenan addressed the Board regarding the interview process. He suggested that he and Wrage sit on the interview committee as current officers of the conservation board and that Melody Bro, Montour, has agreed to serve on the interview committee as an independent resident with an interest in conservation and the programs of the conservation board. There were no objections raised. It is anticipated that interviews will occur the week of February 18- 22.

Donation Request The Jasper County Conservation Board is hosting a kickoff fundraiser on February 23. The event is

to raise funds and awareness of the effort to build a Nature Center in Jasper County. A request was received soliciting a donation to the silent auction. After discussion it was moved by Adolphs, seconded Wacha to donate coupons good for two nights camping at Otter Creek Lake and Park, carried. (all voting aye)

Tama County Tourism Traveler Pocket Guide Etzel shared the Tama County Tourism Committee will be developing a Tama County Tourism Traveler Pocket Guide for publication and use during 2019- 2020. The guides are placed in Iowa Visitor's Centers and in local establishments. The Conservation Board had placed a ½ page ad for Otter Creek Lake and Park in the 2017- 2018 edition. After discussion it was moved by Adolphs, seconded Wrage to purchase a ½ page ad in the 2019- 2020 Tama County Tourism Traveler Pocket Guide for \$200, carried. (all voting aye)



FY '20 Budget Request Etzel presented the proposed budget request for FY '20 to the Board. The Board reviewed and discussed the proposed budget and supporting materials. This budget included adding a full time Conservation Tech 1/Park Ranger position to the existing staff. It has been apparent for several years that there is inadequate staff to address the maintenance and vegetation management requirements of the Board.
